Women at the University of South Florida are 67.47% of the student body, but they are provided just 49.9% of the student-athlete opportunities. To provide athletic opportunities that are substantially proportionate to men's and women's enrolment, or Prong 1, or the "Proportionality Test," South Florida must add 101 additional athletic opportunities for women.

- 7 men's varsity sports (Baseball, Basketball, Football, Golf, Soccer, and Tennis, providing this educational opportunity to 262 men, using the single count

In Champion Women's attached letter, we provide detailed facts that the University of South Florida cannot meet Prong 2 or Prong 3 either.

<u>Champion Women's materials include a chart with 19 years of EADA data showing that the school</u>
<u>does not have "a continuing practice of program expansion which is demonstrably responsive to</u>
<u>the developing interests and abilities of the members of that sex", the requirement for Prong 2.</u>

We demonstrate that the University of South Florida cannot meet Prong 3 of meeting women's interest and athletic ability with the following facts, better detailed in our letter, from:

- South Florida is a member of universities in the American Athletic Conference, where members hail from Florida, Alabama, North Carolina, Tennessee, Texas, Louisiana, Oklahoma, and Texas. Inside this enormous competitive geographic region, USF will not have problems finding new sports to add for women.
- The American Athletic League provides women with 3 championship sports, Lacrosse, Rowing, and Swimming & Diving, which USF does not sponsor.
- Members of the American Athletic League sponsor Beach Volleyball, Rifle, Sailing, Equestrian, Fencing, Field Hockey, Gymnastics, Bowling, 8 sports that South Florida does not sponsor for women.
- The Florida High School Athletic Association sponsors girls' Field Hockey, Lacrosse, Swimming & Diving, Track & Field, Wrestling, Weightlifting, and Water Polo, all sports South Florida does not offer its female students. https://www.nfhsnetwork.com/states/FL
- Girls in Florida also compete in sports not associated with school; club teams, travel teams, AAU and the Olympic and Paralympic sports system, sports like Basketball, Golf, Tennis, Equestrian, Wrestling, Badminton, Table Tennis, Team Handball, Sailing, Field Hockey, Fencing, Swimming & Diving, Skateboarding, Water Polo, Archery, Field Hockey, Rifle, Triathlon, Ice Hockey, Sport Climbing, Artistic Swimming, Skiing, Snowboarding, Gymnastics, Rowing, Wrestling, Rugby, and combat sports, like Judo, Jujitsu, Karate, and Taekwondo.
- College sports, particularly NCAA Division I, is a rare, rationed type of educational experience. According to the NCAA, in 2020, only 1.3% of high school girls basketball players were provided the opportunity to play in Division I. Just 2.9% of high school Field Hockey players, 2.8% of Golfers, 8.9% of Ice Hockey players, 3.7% of Lacrosse players, 2.4% of Soccer players, 1.8% of Softball players, 3.3% of Swimmers, 1.5% of Tennis players, 2.8% of Track & Field athletes, 1.2% of Volleyball players in high school are provided opportunities to play their sport in Division I. These metrics demonstrate that women have expressed enormous demand to compete in sports that

- The percentage of those high school athletes who are provided with a college athletic scholarship is even smaller. Sadly, most of these women think they cannot play a sport in college because they aren't good enough, aren't as good as their male peers, rather than the fact that schools offer girls and women so many fewer opportunities and athletic scholarship dollars.
- The percentage of those high school athletes who are provided with a college athletic scholarship is even smaller. Sadly, most of these women think they cannot play in college because they aren't good enough, rather than the fact that schools offer girls and women so many fewer opportunities.
- Women at the University of South Florida participate in several club sports including equestrian, swimming and diving, rugby, lacrosse, rowing, field hockey, and water polo.
- Champion Women provided the NCAA "emerging sport" list of sports, with sports that the University of South Florida does not offer: women's Wrestling, Triathlon, Rugby, and Equestrian.
- Champion Women also provides links to sport governing bodies, which makes it easy to see where women's teams and potential competitors are located.

We also checked the school's website and found University of South Florida does not provide avenues to add more women's sports, it does not assess the interests and athletic abilities of its students to determine which new sports to add, and its Title IX page is devoted to sexual harassment and violence, ignoring sex discrimination in the athletic department.

The failure to provide women with equal opportunities to play impacts the availability of athletic scholarship dollars for women. These are important sources of funding for educational attainment that women are being denied because of their sex. Women are 57.4 percent of the student body, but just 44 percent of the athletes.

If the University of South Florida provided its male and female students with the same opportunities to participate, the University of South Florida would need to add \$4,276,687 additional athletic scholarship dollars, to balance out the amount University of South Florida provides to its male students. If, for some reason, the OCR determines University of South Florida is, in fact, not discriminating against women in providing opportunities in sport, then the OCR would use the student-athlete ratio, rather than the student body ratio, and the University of South Florida would still need to provide its women students participating in sports with \$1,211,224 more


The University of South Florida needs to give women's teams an additional \$827,993 in recruiting funds, based on enrollment. If, for some reason, the OCR determined that the University of South Florida is, in fact, not discriminating against women in providing opportunities in sport, then the OCR would use the student-athlete ratio, rather than the student body ratio, and the University of South Florida would still need to provide its women's sports teams – and women's coaches – with \$212,110 more recruiting dollars in order to be consistent with the school's investment in men's sports.

In order to address these disparities, *Champion Women* requests that the Office for Civil Rights ("OCR") investigate the University of South Florida to determine whether it is discriminating against women in its athletic department. Additional Title IX violations are expected to be found, including equipment and supplies; game and practice times; travel and per diem allowances; coaching and academic tutoring; assignment and compensation of coaches and tutors; locker rooms, practice, and competitive facilities; medical and training facilities and services; housing and dining facilities and services; and publicity. When violations are found, secure assurances of compliance with Title IX that include full remedies.





In the next two graphs below, notice how women are entitled to much less in athletic scholarship aid and recruiting budgets than the school provides men, if the OCR allows a school to count women multiple times, but not require the same for men, or the OCR does not require Prong 1 or Proportionality. South Florida would need to add \$4,276,687 additional athletic scholarship dollars for women, to balance out the amount it provides to its male students. But if the student-athlete ratio is used, then South Florida would need to provide women with \$1,211,224 in additional athletic scholarship aid. That's quite a loss.
